

CHALK SPORTS, LLC PRIVACY POLICY

Chalk Sports LLC ("us", "we", or "our") operates the http://www.chalkokc.com website and the Chalk Restaurant mobile application (collectively known as the "Service").

This page informs you of our policies regarding the collection, use, and disclosure of personal data when you use our Service and the choices you have associated with that data. TYPES OF DATA COLLECTED

Usage Data
